Thank you for your email of 9 October 2020, requesting information about convicted child sex offenders managed by Corrections. Your request has been considered under the Official Information Act 1982 (OIA).

Public safety is Corrections' top priority and substantial effort goes into the safe management and rehabilitation of people convicted of child sex offences. As you are aware, Corrections does not determine who is in prison and who is in the community. Corrections also does not determine whether a person receives a sentence of imprisonment or a community-based sentence following a conviction, such as Home Detention. These decisions are made by the Courts or New Zealand Parole Board.

You requested the following information relating to child sex offenders and rehabilitation from 2015/16 to 2019/20:

- 1) How many convicted CSOs were incarcerated in 2016, 2017, 2018, 2019, 2020 fiscal years?
- 2) Of the above numbers in question 1) please breakdown by age, gender and ethnicity?
- 3) How many convicted CSO's were given Home Detention in 2016, 2017, 2018, 2019, 2020?
- 4) Of the above numbers in question 3) please breakdown by age, gender and ethnicity?

Please find enclosed, Appendix One with this information from 2015/16 to 2019/20. The numbers identified are relatively low, so we caution against drawing conclusions about trends based on a small data set.

- 5) How many convicted CSO's incarcerated in question 1) had their name changed or used an alias?
- 6) How many convicted CSO's given Home Detention in question 3) had their name changed or used an alias?

The information may be held on an offender's individual electronic file and relies on external sources, we do not hold data in a readily retrievable format to answer this part of your request. Therefore, this part of your request is declined in accordance

with section 18(g) of the OIA, as the information requested is not held by Corrections, and we have no grounds for believing that it is held by another agency or more closely connected with the functions of another agency.

Please note that the Ombudsman has advised that information is not considered to be held by an agency in instances where a request necessitates research or analysis of source data in order to generate fresh information in a form different from that in which the base data is held.

7) How many incarcerated CSO's attended a rehabilitation course in 2016, 2017, 2018, 2019 and 2020?

Please find enclosed Appendix Two with information on the number of people in prison convicted of child sex offences who attended any rehabilitation course delivered by Corrections from 2015/16 to 2019/20. Information is provided by financial year in line with our standard reporting conventions. Individuals may be counted more than once as they can attend more than one rehabilitative programme.

When reviewing changes in the figures from year to year for any programme, please note that people are considered for programmes based on their individual needs, risk factors and responsivity. Eligibility and suitability for placement onto a programme can include an assessment of the individual's offending history, risk level, security classification, language comprehension, cognitive ability, mental health, motivation, and the level to which they have taken responsibility for their offending.

You may note some significant decreases in participant figures in the 2019/20 period, which has occurred due to the impact of COVID-19.

Please also note that the delivery of programmes and fluctuations between years can be influenced by factors including available funding and assessments of what programmes are most effective. For example:

- The AOD brief support programme ceased in 2018 when Corrections decided to focus on longer treatment options that were found to be more effective,
- The AOD Intermediate Treatment Programme was discontinued in the same year as the DTP6 Drug Treatment Programme was found to be more effective.
- The Short Intervention Programme Child Sexual Offending increased participation in 2018/19 period was due to a time specific increase in funding for the delivery of this programme to a targeted group.
