

**Appendix Two – summaries of serious prisoner-on-prisoner assaults between 2015/16 and 2020/21.**

Region	Year	Summary of incident
Central	2015/16	Victim sustained fractured jaw in an assault.
Northern	2015/16	Victim sustained fractures to arm, skull, jaw and perforated eardrum.
Southern	2015/16	As a result of the assault, victim required finger to be amputated.
Northern	2015/16	Victim sustained head injuries and stab wounds.
Lower North	2015/16	Victim sustained ruptured spleen.
Southern	2015/16	Victim sustained injuries to nose requiring surgery and possible facial fractures.
Northern	2015/16	Alleged sexual assault.
Lower North	2015/16	Both of the victims' cheekbones were fractured, both sinus areas fractured, broken nose and two teeth knocked out.
Northern	2015/16	Victim sustained swelling around head area and mouth, multiple puncture wounds on back, most are open weeping wounds.
Lower North	2015/16	Victim sustained a bruise to the spleen, broken rib and punctured lung.
Lower North	2015/16	Victim sustained a fractured jaw that required necessary operation to have jaw pinned back into place.
Central	2015/16	Victim sustained head injuries and was unconscious for a few minutes after the assault. Victim stayed overnight at hospital.
Lower North	2015/16	Victim sustained brain injury and underwent surgery to remove bone fragments and relieve pressure to their brain.
Northern	2015/16	Victim sustained a lacerated spleen.
Northern	2015/16	Victim was assessed and treated at hospital, there was follow-up surgery to treat a fractured eye socket.
Northern	2015/16	Alleged sexual assault.
Lower North	2015/16	Victim appeared to be unwell with red rashes around their head and neck. When checked by the nurse, it was confirmed received heavy blows after a confrontation.
Northern	2015/16	Victim was stabbed on upper thigh. Victim is receiving on-going medical treatment for an infection in leg as a result of the assault.
Northern	2015/16	Victim was punched twice on face by the perpetrator. Victim sustained broken (lost) tooth. Perpetrator was placed in directed segregation.
Northern	2015/16	Victim sustained facial injuries. They were sent to hospital for further examination of their eye. Eye surgery required.
Lower North	2015/16	Victim was assaulted with a broom handle in an unprovoked attack. They were hit several times on the head. Victim was sent to Hastings for further medical checks.
Lower North	2015/16	Victim sustained serious ear injury that required surgery. Victim also remained in hospital for two days.
Lower North	2015/16	Perpetrator bit off a part of the victim's ear during an altercation. Victim was sent to hospital for treatment.
Northern	2015/16	Victim sustained a broken ankle, shoulder injury, missing teeth and other facial injuries.
Southern	2015/16	Victim sustained a fractured skull and damaged spleen. Will remain in hospital for 4-5 days.
Northern	2015/16	This is an alleged sexual assault.
Lower North	2015/16	Victim sustained cut on left ear and cuts to face.
Southern	2015/16	Victim sustained two facial fractures as a result of the assault and required overnight stay at hospital.

Region	Year	Summary of incident
Lower North	2015/16	Victim sustained mouth injuries and cut on the right side of upper lip. Blood was coming out of mouth. Victim was sent to hospital for treatment.
Northern	2015/16	Victim lost a number of teeth.
Lower North	2015/16	Victim was punched and sustained a long tear from the inside of ear through to ear lobe.
Southern	2015/16	Victim sustained head injury and cuts and swelling to right eye. Injuries sustained requires on-going medication
Lower North	2015/16	Victim sustained a fractured skull and a broken finger on right hand as a result of the assault inflicted.
Central	2015/16	Victim sustained jaw injury that requires surgery.
Southern	2015/16	Threw hot water on victim's face resulting to serious burns.
Lower North	2015/16	Perpetrator threw hot water on the victim. Victim was admitted to hospital.
Southern	2015/16	Victim sustained serious head injuries. They were sent to hospital for medical treatment. When victim returned to prison, they were admitted to Health Unit for overnight observation.
Lower North	2015/16	Sustained a broken jaw as a result of the assault.
Southern	2015/16	Victim sustained a broken jaw as a result of this incident
Southern	2015/16	Victim sustained a fractured orbital eye socket and a hematoma behind the eye. The victim was taken to hospital for treatment.
Lower North	2015/16	Victim sustained a fractured jaw as a result of the assault
Northern	2015/16	Victim sustained a broken jaw that required surgery (plates placed in his jaw).
Southern	2015/16	Victim sustained a fractured jaw. They underwent surgery and will remain in hospital for a couple of days.
Southern	2015/16	Victim sustained a broken leg. Victim underwent surgery to repair the fracture in leg. Hospitalized for days.
Lower North	2015/16	Victim sustained a fractured nose, extensive cuts and bruises.
Northern	2016/17	Victim sustained a huge cut under left eye, swelling on left face and a broken tooth. Victim was hospitalised for a night due to a broken eye socket.
Northern	2016/17	This is an alleged sexual assault. Perpetrator was accused of touching the victim inappropriately in the groin area.
Northern	2016/17	Victim sustained serious head and facial injuries after being assaulted by three prisoners. Victim had to be carried off the place where the assault happened. They were assessed and continued to be monitored at the Health Unit up to the time the ambulance arrived and took them to hospital.
Lower North	2016/17	Victim sustained head injuries and was taken to medical for check-up.
Northern	2016/17	Victim was punched and stabbed with a shank. They were sent to hospital for treatment. They stayed at At Risk unit upon return to prison for monitoring.
Northern	2016/17	Victim suffered concussion caused by heavy blows on the head and stomach. They received medical assistance and sent to hospital for further treatment.
Southern	2016/17	Victim sustained damaged eye sockets and spinal fractures. They remained in hospital overnight.
Northern	2016/17	Victim sustained injuries that required stitching. They also had seizures as a result of the assault. Victim was hospitalised for the night.

**Appendix Two – summaries of serious prisoner-on-prisoner assaults between 2015/16 and 2020/21.**

Region	Year	Summary of incident
Northern	2016/17	Victim was hit by a broom on back and stabbed around the neck area with the broken end of the broom handle. Prisoner was taken to hospital by ambulance.
Southern	2016/17	Victim sustained a broken nose and broken eye socket. Went to surgery.
Northern	2016/17	Victim sustained a broken jaw as a result of the assault.
Central	2016/17	Two offenders/victims. One offender sustained a broken jaw and the other a fractured thumb. Both were seen by the A&E team and were both sent back to the hospital for further treatment. One stayed in hospital for two days, while the other one stayed for only a day.
Lower North	2016/17	Injuries sustained include a broken jaw and fractured skull.
Lower North	2016/17	injuries sustained by victim required overnight stay at the hospital.
Lower North	2016/17	Prisoner was escorted to hospital for observation and assessment. Victim received 10-12% superficial and partial thickness burns along with superficial bruising and cuts.
Lower North	2016/17	Victim was found unconscious by the officers and suffered seizures as a result of the assault. Victim suffered a fractured jaw and was taken to hospital for assessment.
Central	2016/17	Victim sustained a broken jaw from the assault. Injury required surgery.
Southern	2016/17	Victim was found unconscious as a result of the assault. Sent to hospital.
Northern	2016/17	Prisoner assaulted in yard.
Lower North	2016/17	Prisoner mentioned that they had been assaulted whilst sitting in the day room waiting for the phone. Victim had blood in mouth and was struggling to move jaw.
Central	2016/17	Two offenders/victims. Although this started as a fight, injuries sustained by two offenders are deemed serious. One offender sustained a puncture wound caused by a foreign object (a shank was recovered later from one of the perpetrators). The other offender suffered concussion, swollen and bruised area around right eye. Both were sent to A&E and required extended period of ongoing medical treatment.
Northern	2016/17	Victim sustained a broken jaw from the assault.
Northern	2016/17	Victim sustained a broken jaw from the assault.
Northern	2017/18	Surgery required for a broken jaw that victim sustained as a result of assault.
Lower North	2017/18	Victim requires plastic surgery due to lacerations and fractured right eye socket, also has a broken nose.
Northern	2017/18	Victim sustained a broken jaw as a result of the assault. Was sent to hospital for treatment.
Southern	2017/18	Victim sustained a fractured leg as a result of the hospital. X-ray result shows a crack on their leg.
Central	2017/18	Victim suffered broken jaw that required surgery. Victim was sent to hospital for jaw surgery.
Southern	2017/18	Victim suffered broken eye socket that required surgery and a bleeding nose.
Southern	2017/18	Victim sustained a fractured orbital and will require surgery where they will have a titanium plate and three screws put into their face.
Northern	2017/18	Victim sustained facial injuries and was later sent to hospital where they underwent surgery.

Region	Year	Summary of incident
Northern	2017/18	Victim sustained multiple stab wounds to face, neck and upper body as a result of the assault.
Northern	2017/18	Victim sustained injuries that required an overnight stay at the hospital. They were discharged after a day and placed in ARu for further observation.
Lower North	2017/18	Victim was hospitalised and remained overnight.
Northern	2017/18	Victim sustained stab wounds to the neck and head. Victim did not require overnight hospitalisation.
Lower North	2017/18	Two victims - one victim sustained fractured ribs and the other serious facial injuries. Both were seen by medical and will require on-going treatment.
Northern	2017/18	Victim sustained a broken arm.
Northern	2017/18	Victim sustained cuts on head which required stitches (four cuts on head). Victim was placed under observation.
Southern	2017/18	Victim suffered seizures. Victim was punched and fell on the concrete floor. They were rushed to hospital for treatment as their condition was assessed as serious.
Lower North	2017/18	Victim sustained a large lump (approximately two inches wide and very prominent) on the back-right hand side of head. Victim also had a mark under right eye that would be consistent with being punched. They were found having a seizure after the attack. Medical staff who checked on victim stated that they would need to be transported to hospital for full assessment.
Southern	2017/18	Victim was found lying on the ground by staff who responded to the incident. Victim was knocked down as a result of the assault. They were disoriented and not even aware why they were in prison. Victim was held in the medical bed on observation for a period of time, as there was concern of the large lump on the back of head and their confused state.
Northern	2017/18	Two victims: Both victims sustained serious head injuries as a result of the assault. One offender was sent to hospital via ambulance for treatment. The other tried to ignore their injuries but was later assessed to be needing medical treatment and was sent to hospital for further treatment.
Northern	2017/18	Victim sustained multiple stab wounds to head, back and leg. Was bleeding profusely when officer found them.
Northern	2017/18	Victim sustained around 20 stab wounds to the back of their upper arms and shoulder blades and had bleeding around mouth (teeth).
Northern	2017/18	Victim sustained a cut on upper lip that needs stitching. Victim was sent to the hospital.
Southern	2017/18	Victim sustained an orbital fracture (eye) and nose. They were hospitalised for more than 10 days for treatment and was admitted to the health unit when victim returned to prison.
Southern	2017/18	Victim was taken to hospital for treatment of damage to the eye socket/cheek area as a result of the assault.
Lower North	2017/18	Victim sustained skin burns as a result of the assault and was hospitalised for a night.
Southern	2017/18	Victim sustained serious facial injuries that required an overnight stay at the hospital.
Southern	2017/18	Victim suffered neck injuries deemed to be serious.
Northern	2017/18	Victim received heavy punches from the perpetrator. Victim was rushed to the hospital by an ambulance.
Central	2017/18	Victim sustained injuries to right eye. Victim also sustained injuries on the mouth and nasal area.

Region	Year	Summary of incident
Northern	2017/18	Victim sustained injuries to their left eyebrow which was cut, swelling to the left side of their face and swollen knuckles on their left hand.
Southern	2017/18	Victim sustained a fractured jaw as a result of the incident.
Northern	2017/18	Victim was stabbed on his leg and sustained a cracked rib as a result of the assault.
Central	2017/18	Victim sustained the following as a result of the assault: swollen eyes, brushing and bleeding around the eye area.
Northern	2017/18	Victim sustained a deep cut on arm as a result of the assault.
Northern	2017/18	Victim sustained serious head injuries. Victim was found lying on the ground covered with blood gushing from their head.
Southern	2017/18	The victim's condition as a result of the injuries was deteriorating. The victim was moved to hospital by ambulance.
Southern	2017/18	Victim was treated by medical for broken tooth.
Northern	2017/18	Victim was kicked at the back by perpetrator. Victim fell face first into the grill. Victim sustained facial injuries. Health staff recommended that victim be sent to hospital for further treatment.
Northern	2017/18	Victim sustained a broken jaw.
Northern	2017/18	Victim sustained a broken jaw as a result of the assault.
Southern	2018/19	Victim sustained a swollen face and bruised with blood coming from nose. Victim was unresponsive to start with. Victim was brought to hospital and was kept on health bed when returned to prison - requires on-going medication.
Lower North	2018/19	Victim sustained multiple bruises on face and appeared visibly distressed. Victim was semi-conscious and struggling to stay upright. Medical staff who attended to victim called an ambulance and they were taken away to hospital for treatment.
Lower North	2018/19	Victim sustained visible injuries down the right side of face and was losing consciousness. Victim was taken to hospital for further medical treatment.
Southern	2018/19	Victim sustained broken wrist (both wrists).
Lower North	2018/19	Victim sustained facial injuries as a result of the assault. Victim was also suffering from seizures and was hospitalised due to injuries sustained.
Lower North	2018/19	Victim sustained serious injuries to mouth area, and blood was streaming out of mouth. Victim was also having extreme problems breathing.
Southern	2018/19	Victim was hospitalised for almost three nights.
Lower North	2018/19	Victim received multiple blows to head. They lost consciousness and were hospitalised as a result of the assault.
Southern	2018/19	Victim received heavy blows on the face. Victim was taken to hospital via ambulance and was hospitalised overnight and was taken for surgery the next day.
Lower North	2018/19	Victim lost consciousness as a result of the attack. Victim's condition worsened and was declared life threatening by medical staff.
Southern	2018/19	Victim sustained a fractured eye socket as a result of the assault.
Lower North	2018/19	Victim sustained a fractured nose and requires ongoing checks from medical as a result of the assault.
Lower North	2018/19	Victim sustained serious neck injuries, was in the Intensive Care Unit for days and transferred to another hospital for further treatment. Victim was paralysed as a result of the injuries.

Northern	2018/19	Victim sustained injuries that requires regular monitoring by health staff
Southern	2018/19	Victim's throat was slashed by an improvised knife, while bleeding profusely because of the cut the perpetrator kept on kicking the victim on the floor.
Central	2018/19	Victim sustained a broken arm that requires surgery.
Lower North	2018/19	Victim suffered a broken nose and fractures to left cheek bone.
Northern	2018/19	Injuries sustained are right orbital fracture, nasal bone fracture. and right eye soft tissue injury
Northern	2018/19	Injuries sustained might require surgery. Victim's condition deteriorated a day after the assault and they were escorted back to hospital for further treatment
Lower North	2018/19	Victim sustained a broken hip and spent three nights in hospital.
Southern	2018/19	Victim sustained serious facial injuries that required an overnight stay at the hospital.
Lower North	2018/19	Victim was taken to hospital for the injuries sustained and requires further treatment to facial area due to fractures sustained. Victim spent the night at the hospital.
Lower North	2018/19	Victim sustained a broken jaw as a result of the assault.
Lower North	2018/19	Victim sustained a broken jaw.
Lower North	2018/19	Victim sustained injuries that requires regular monitoring by health staff.
Lower North	2018/19	Victim was stabbed around six times around the hip and thigh area. Victim was repeatedly kicked and punched.
Central	2018/19	Victim was struck with a blunt object multiple times to the body and to the face area.
Southern	2018/19	Victim suffered from concussion as a result of the assault. Victim appeared incoherent and confused. They were also seen with their head over the toilet spitting blood and complaining of headache.
Northern	2018/19	Victim sustained a fracture as a result of the assault. They were taken to hospital by ambulance for assessment and admitted to stay at hospital.
Lower North	2018/19	The victim sustained fractured eye socket.
Northern	2018/19	Victim sustained facial burns and was struck by a pen on neck and head area.
Lower North	2018/19	Victim was bleeding from nose and mouth. Injuries sustained required two nights of stay in hospital.
Lower North	2018/19	Injuries sustained by the victim - swelling on left side of face. Victim was sent to hospital for a check-up.
Northern	2018/19	Victim suffered facial injuries and bleeding from the mouth.
Northern	2018/19	Victim sustained multiple stab wounds to head and back areas with one very large and deep wound below right ear area.
Northern	2018/19	The victim was rendered unconscious as a result of the assault.
Lower North	2018/19	Victim sustained serious head injuries. The victim went to hospital and required brain surgery for the head injury.
Northern	2018/19	The victim sustained serious head injuries, after being stomped and kicked on the head. Victim was brought to hospital via ambulance.
Northern	2018/19	Victim sustained a cut on lip and was taken to hospital for stitches.
Lower North	2018/19	Victim sustained multiple lumps all over face as a result of punching and kicking.

Central	2018/19	Victim sustained facial injuries (black eye and a badly bruised face) as a result of the assault.
Lower North	2018/19	Victim sustained multiple abrasions and contusions due to assault. Victim experienced difficulty in breathing and complained of sore head. Victim said they were beaten and stomped on by a number of prisoners shortly after being locked up.
Southern	2018/19	Victim was hospitalised, had a broken jaw in two places, fractured cheek bone and damaged teeth, and lots of swelling in the facial area.
Lower North	2018/19	The victim received fractures as a result of the assault.
Northern	2018/19	Victim was found lying on the ground in a pool of blood. They sustained serious head injuries.
Northern	2018/19	Victim sustained injuries that required an overnight stay at hospital. Victim underwent a CT scan.
Central	2019/20	Victim lost two teeth and ended up with a bleeding nose as a result of the attack.
Northern	2019/20	Victim sustained facial bruising and a fracture requiring further hospital treatment.
Southern	2019/20	Injury sustained by victim - spinal fluid leaking from nose. Victim was brought to hospital again a day after the assault because of health issues (spinal fluid leaking from nose).
Lower North	2019/20	Victim was stabbed and thrown with hot water.
Lower North	2019/20	Victim received a broken jaw that required surgery at hospital.
Northern	2019/20	Victim appeared dazed when the doctor assessed them after the assault. The victim sustained deep laceration with swelling and bruising to right brow, swelling and abrasions right cheek and right ear, also swelling and redness to right temple.
Central	2019/20	Victim sustained serious facial and head injuries as a result of the attack. Victim suffered concussions.
Southern	2019/20	The victim was taken to hospital for an x-ray. Confirmed that they had a broken jaw.
Northern	2019/20	Victim sustained serious head injury as a result of the assault.
Northern	2019/20	Victim was sent to the hospital for suspected fracture on left shoulder after the incident. The x-ray confirmed that there was fracture. Victim also received a cut on ear which was treated at the hospital.
Central	2019/20	Victim sustained head injuries that required five stitches.
Northern	2019/20	Victim sustained swollen forehead, bleeding nose and a swollen eye as a result of the assault. Victim was assessed by medical staff and was referred for an x-ray.
Lower North	2019/20	Prisoner sustained a broken jaw as a result of the assault.
Southern	2019/20	Victim was knocked to the ground by another prisoner, resulting to a broken leg (lower right leg).
Northern	2019/20	Victim sustained facial injuries around the nose area and a severe laceration to lower lip.
Central	2019/20	Victim sustained a broken tibia that required surgery/cast.
Southern	2019/20	Victim was punched on the jaw. Injuries reported include a broken jaw and several shattered teeth. Hospitalisation was required and a directed segregation was sought and approved.
Lower North	2019/20	Victim received three unprovoked punches on the head. They were knocked down to the ground and lost consciousness. When victim gained consciousness, they needed help to stand because they were unsteady on their feet.

Lower North	2019/20	Staff attended the cell and noticed there was an assault/fight taking place. The victim received multiple injuries
Southern	2019/20	Staff saw prisoners punching victim in yard.
Lower North	2019/20	Staff arrive to investigate and notice some blood on the ground. They notice an injury to the victim on their right hand
Southern	2019/20	Victim was approached and hit in the jaw area.
Northern	2019/20	Prisoner stabbing the victim.
Lower North	2019/20	Prisons fighting.
Southern	2019/20	Due to the severity of his injuries, victim was housed overnight in the Intensive Supervision Unit before being escorted to hospital.
Southern	2019/20	Victim sent to hospital overnight.
Lower North	2019/20	Victim refused medical assistance but was later seen to.
Central	2019/20	Ambulance was called due the seriousness of the injury and the victim sent to hospital.
Lower North	2019/20	Victim had multiple facial fractures and escorted to ENT Clinic for further treatment.

Central	2019/20	This is an alleged sexual assault.

Southern	2020/21	Suspected that the victim had sustained a broken jaw and would need to go to hospital.
Southern	2020/21	The victim was punched in the head multiple times. As a result of this assault, the victim was hospitalised with injuries.
Central	2020/21	The victim was bleeding from the head and mouth. The other occupant of the cell was found pacing back and forward in the cell in an agitated state.
Northern	2020/21	A fight broke out and the victim suffered a broken jaw and other head injuries.
Lower North	2020/21	Prisoners entered the kitchen and assaulted the victim while being returned to their unit from the yard. Victim suffered a suspected finger fracture of right hand.
Northern	2020/21	Two victims: found unconscious and bleeding heavily from the head.
Central	2020/21	Victim was seriously assaulted. The assault resulted in several stitches being applied to the injuries
Northern	2020/21	Victim advised that they had a broken wrist and a sore eye. The victim advised that they woke up like that and do not remember what happened.
Northern	2020/21	Alleged sexual assault.
Southern	2020/21	Victim was punched in the head with a closed fist.
Northern	2020/21	Victim advised they were coming out of their wing for medication when they were assaulted by their cellmate. Victim had a red mark on lower right jaw line. Assessed as having a broken jaw and was taken to hospital.
Southern	2020/21	Victim appeared to have sustained a minor puncture wound to arm and medical staff treated this on site.
Northern	2020/21	The victim was seen by health staff because they were observed having facial bruising. Victim was assaulted in the exercise yard on two occasions by three prisoners.
Northern	2020/21	While staff were moving a prisoner back to their cell, the prisoner threw a cup of hot melted sugar over victim.
Southern	2020/21	Victim had some injuries to his face and was sent to hospital. Victim was admitted and returned to site the next day.
Northern	2020/21	Perpetrator kicked victim on the face and body area.
Northern	2020/21	Gangs fighting in the exercise yard.
Northern	2020/21	An assault had taken place in the yard. Victim confirmed they were assaulted by two other prisoners.
Southern	2020/21	Victim advised they had been sexually assaulted by other prisoner/s.
