Thank you for your email of 12 February 2021, requesting information about investigations into Corrections staff. Your request has been considered under the Official Information Act 1982 (OIA).

Firstly, I would like to apologise for the delay in responding to your request. Thank you for your patience.

Corrections expects the utmost professionalism from our employees, and allegations of staff misconduct are taken seriously. All employees are held to a high standard of integrity and professionalism and must act as role models for the people and the communities we work with. All staff are expected to work in accordance with Corrections' Code of Conduct and any behaviour which conflicts with the Code is not acceptable.

Any large organisation may encounter some staff who do not maintain the high standards set by the organisation, and when staff do not meet the standards required of them, we take the appropriate action. This may involve further development or support to bring the staff member's performance up to the standard required. Serious misconduct may result in disciplinary action, which could include staff being suspended pending the outcome of an investigation, or the termination of employment.

A number of initiatives have been implemented in recent years to strengthen integrity and ensure that it is embedded in the culture of our workplace. This series of initiatives includes:

- increased pre-employment checks, including integrity questions and conflict of interest questionnaires,
- the establishment of an Integrity Committee and the inclusion of an integrity focus into all Department risk management frameworks,
- extra resources for management teams to consider integrity examples and issues on a regular basis,



- the introduction of a learning module for staff to discuss how to speak up effectively to prevent harm, and
- the launch of the 0800 Integrity Support Line, through which staff can report concerns of wrongdoing.

## You requested:

Under the Official Information Act I would like to request the following information for each of the last five years:

The number of Corrections staff who have been investigated at work, where they worked, what the investigation was for, the outcome of the investigation.

Appendix One provides the following information, provided by financial year in line with Corrections' usual reporting conventions:

- Table One: Number of Corrections staff investigated between 2015/16 and 2019/20, broken down by reason for investigation.
- Table Two: Number of Corrections staff investigated between 2015/16 and 2019/20, broken down by location.
- Table Three: Number of Corrections staff investigated between 2015/16 and 2019/20, broken down by investigation outcome.

Corrections conducts a broad range of investigations that vary between misconduct and serious misconduct on a case by case basis. Note that some staff misconducts may not be represented in the data where no further investigation is required, such as disciplinary action following a traffic infringement. The figures above represent all instances where an investigation was subsequently required.

Please note that this response may be published on Corrections' website. Typically, responses are published quarterly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.
